New Start: Approval will be for 6 months

FDA Indications:

Bavencio

- Merkel cell carcinoma, Metastatic
- Metastatic urothelial carcinoma, Or locally advanced, first-line maintenance in patients with no progression following first-line platinum-containing chemotherapy
- Metastatic urothelial carcinoma, Or locally advanced, with progression during or after platinum-containing chemotherapy or within 12 months of neoadjuvant or adjuvant treatment with platinum-containing chemotherapy
- Renal cell carcinoma, Advanced, first-line treatment in combination with axitinib

Torisel

- Renal cell carcinoma, Advanced

Off-Label Uses:

Torisel

- Mantle cell lymphoma, Relapsed or refractory

Age Restrictions:

Torisel: Safety and effectiveness not established in pediatric patients

Other Clinical Considerations:

Cancer diagnoses: Criteria as per NCCN or other FDA-approved cancer related guidelines.
